School Year 2020- 21 Distance Learning Plan	Mr. Rob Pecharich presented on the current guidance by the Pima County Health Department recommendation that it is not currently safe to reopen schools based on the current COVID-19 measures within the community. The Edge High School Distance Learning Plan outlines the schools plan to support students and staff in distance learning, social emotional support, attendance tracking, benchmark testing and support of populations with greater need including Special Education, Homeless, and English Language Learners. Mr. Pecharich asked that the board plan to review County Health Department metrics on a monthly basis to review conditions for possible change to hybrid learning once possible. The current plan does include offering limited capacity on site space for students to attend their online instruction. The Arizona Department of Education is expected to provide further guidance regarding specific populations to be support in onsite space. Mr. Greg Hart, Executive Director, discussed the need to consider the safety and health of the students and staff and that the current environmental risks are too great. Ms. Gloria Proo, Board Member, encouraged staff and board members to consider ways to engage with students and teachers to continue to identify ways to measure how students are doing academically and socially if online instruction continues further into the school year. This will help target future grant needs based on target areas of needed support. Brittany Battle made the following motion - Motion to accept the Distance Learning Plan as amended, to begin the school year in Distance Learning with a plan to review the Pima County and Arizona Department of Health Metrics on a monthly basis to consider future hybrid instruction.
