Universal and correct wearing of masks	Y	Effective August 19, 2021 face masks are required indoors while on campus for all students, staff, support persons and visitors. In accordance with Arizona Education Bill HB2898, the LEA may not require the use of face masks effective September 29, 2021.
Modifying facilities to allow for physical distancing (e.g., use of cohorts/podding)	Y	The LEA Mitigation plan outlines the guidelines for implementing 3 feet of physical distancing whenever possible while indoors. The plan also recommends 6 ft physical distancing for unvaccinated individuals.
Handwashing and respiratory etiquette	Y	The LEA Mitigation plan outlines training practices for students and staff on proper handwashing and respiratory etiquette, as well as placement of signage throughout the school facilities.
Cleaning and maintaining healthy facilities, including improving ventilation	Y	The LEA Mitigation plan includes cleaning procedures for each school site for disinfecting and addressing high touch point areas. The plan also includes implementation of air filtration systems in each classroom.
Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments	Y	The LEA Mitigation plan includes recommendations for at home screening for symptoms of illness and the availability of BinaxNOW Rapid Antigen Testing for students and staff. The school follows CDC guidelines for all individuals who are symptomatic to isolate for 10 days. The school also follows CDC guidance of 5 days of quarantine after close contact with someone who tests positive for COVID based on vaccination status. After Day 5 the individual can test at the school or another facility and return if the test result is negative. All on campus tests are reported to the Arizona Department of Health Services. All COVID positive staff and student test results are reported to the Pima County Health Department and contact tracing is performed for all school locations of the school, as needed.
Diagnostic and screening testing	Y	The LEA Mitigation plan includes recommendations for at home screening for

Appropriate accommodations for children with disabilities with respect to health and safety policies	Y	The LEA Distance Learning and Mitigation Plans include accommodations in place for continuity of services and health and safety support
Coordination with State and local health officials	Y	The LEA Mitigation Plan includes guidance as provided in coordination with Center for Disease Control, Arizona Department of Health Services and Pima County Health Department.

How the LEA will Ensure Continuity of Services?

The LEA Distance Learning Plan includes the continuity of services and supports beyond in person instruction including hybrid instruction and remote learning when designated by health officials based on the community spread of the pandemic. The LEA is prepared to operate in either hybrid or distance learning environments with learning devices for each student, fully equipped online curriculum and instructional class time through virtual environments. All student support services and on-site support services would be available to students during distance learning, including on-site learning room and counseling services.

Students' Needs:

Academic Needs	As outlined in the updated Distance Learning Plan 2021-22, the school curriculum is fully accessible online and integrated within Google Classroom. Should Hybrid or Distance Learning be necessary, students will transition to one on one device off site or attend on-site support services. The Multi-tiered System of Supports Model will be used to review student progress growth and identify needed interventions to continue student learning.
Social, Emotional and Mental Health Needs	The LEA is implementing a multi-tiered approach to Social, Emotional and Mental Health needs by introducing a research based SEL learning platform for both on going elective courses and intervention supports. There are also on site counseling services and a 24-hour counseling hotline for students.
Other Needs (which may include student health and food services)	The school does not have a health or food service program. Students meet with the School Principal and Counselor to identify any barriers to their personal well being that the school can support.

Staff Needs:

Social, Emotional and Mental Health Needs	As outlined in the Distance Learning Plan, multiple avenues are meant to check in on staff Social, Emotional and Mental Health, including weekly PLC or campus meetings, one on one meeting with site principals, staff surveys and a no cost Employee assistance program with 24hr counseling services.
Other Needs	The School Principal at each campus are charged with meeting with staff to identify supports needed. This information is also reported in aggregate to the Governing Board as needed to identify other school needs of staff.

The Distance Learning Plan and Mitigation Plan have been posted to the school website and a message has been sent to all enrolled families for their review and input on the continuity of services and mitigation protocols through a survey form. The Plan was provided to board members and community partners for their input on the implementation. Recommendations based on the plan review are presented to the School Safety and Administration Teams, implemented where they improve the services and support of students and staff and meet the required guidelines then in place and presented to the governing board for review and approval.

The original plans which precede the ARP are scheduled for revision based on all feedback by August 5, 2021, and will be included for review and revision at the last board meeting of each quarter (December 2021, March 2022, June 2022, September 2022, December 2022, March 2023, June 2023, September 2023)
